The Mayor and Board of Aldermen/Alderwoman of the Town of Port Barre met in regular session in the town hall on Tuesday, February 5, 2019, at the hour of 6:00 p.m.

Mayor Ardoin called the meeting to order. Present were: Robin, Barron, Pickney and Hardy. Absent: Abshire.

The Mayor and Board of Aldermen/Alderwoman of the Town of Port Barre, Parish of St. Landry, State of Louisiana, were duly convened as the governing authority of said town by Mayor John P. Ardoin, whom stated that the Council was ready for the transaction of business.

Motion by Robin, seconded by Barron, accepting the minutes of the Regular Meeting held on January 2, 2019, and to dispense with the reading thereof. Unanimous.

Motion by Pickney, seconded by Hardy appointing Mr. John Lamury and Mr. Michael Savant to serve a two-year term as board members on St. Landry Parish Fire District No. 2's Fire Board. Unanimous.

Mayor Ardoin called upon Messrs. Burton and Brad Kolder with the accounting firm of Kolder, Slaven & Company, who presented the fiscal year 2017/2018 audit of the Town of Port Barre.

Motion by Robin, seconded by Pickney to accept the fiscal year 2017/2018 audit by the accounting firm of Kolder, Slaven & Company. Unanimous.

Mayor Ardoin called upon Chief Boudreaux. Chief Boudreaux's secretary, Ms. Nikki Quebedeaux, was present on his behalf and rendered the monthly report of the Police Department.

Mayor Ardoin called upon Mrs. Erin Quebedeaux, Parks & Recreation Director, who rendered her monthly activity report on Youth League and Parks Department activities. She also announced her plans for doing some fund raising activities for the department, and summer activities for the children.


Mayor Ardoin called upon Chad Mayer, Town Supervisor, who rendered a report on street and utility department repairs and maintenance.
