REGULAR MEETING

The Mayor and Board of Aldermen/Alderwoman of the Town of Port Barre met in regular session in the town hall on Tuesday, June 2, 2020, at the hour of 6:00 p.m.

Mayor Ardoin called the meeting to order. Present were: Pickney, Barron, Abshire and Robin. Absent: Hardy.

The Mayor and Board of Aldermen/Alderwoman of the Town of Port Barre, Parish of St. Landry, State of Louisiana, were duly convened as the governing authority of said town by Mayor John P. Ardoin, whom stated that the Council was ready for the transaction of business.

Motion by Robin, seconded by Abshire, accepting the minutes of the Regular Meeting held on May 5, 2020, and to dispense with the reading thereof. Unanimous.

Mayor Ardoin gave an update on business items from last month's meeting.

Motion by Pickney, seconded by Barron adopting a Resolution setting the General Alimony Millage Rate of 5.150 mills for the tax year 2020. Unanimous.

Motion by Robin, seconded by Barron selecting the Daily World newspaper as the official journal for the Town of Port Barre. Unanimous.

Mayor Ardoin called upon Mr. Ricky Broussard with Waterworks District No. 3, who gave an update of the progress of the extension to the North Wilderness section of Three Mile Lake, and other related matters.

Mayor Ardoin presented the departmental reports of the Public Works Supervisor and Parks and Recreation Director.

Mayor Ardoin called upon Chief Boudreaux. Chief Boudreaux rendered his monthly report, and recommended to the council to hire Mr. Richard Truax, Jr. as a full-time dispatcher.

Motion by Pickney, seconded by Barron to hire Mr. Richard Truax, Jr. as a full-time dispatcher for the Police Department. Unanimous.

Motion by Pickney, seconded by Barron to go into Executive Session regarding personnel matters. Council went into Executive Session at approximately 6:38 p.m.

Motion by Abshire, seconded by Pickney to return to Regular Session. Council returned to Regular Session at approximately 7:16 p.m.

Mayor Ardoin called upon the Town Council, then the audience. General discussion was had, including the water and wastewater facilities, re-opening Veterans' Memorial Park, streaming of council meetings, drainage and sewer issues.
