## COUNCIL PROCEEDINGS

DECEMBER 4, 2019

### REGULAR MEETING

The Mayor and Board of Aldermen/Alderwoman of the Town of Port Barre met in regular session in the town hall on Wednesday, December 4, 2019, at the hour of 6:00 p.m.

Mayor Ardoin called the meeting to order. Present were: Barron, Hardy and Robin. Absent: Abshire and Pickney.

The Mayor and Board of Aldermen/Alderwoman of the Town of Port Barre, Parish of St. Landry, State of Louisiana, were duly convened as the governing authority of said town by Mayor John P. Ardoin, whom stated that the Council was ready for the transaction of business.

Motion by Barron, seconded by Hardy, accepting the minutes of the Regular Meeting held on November 5, 2019, and to dispense with the reading thereof. Unanimous.

Mayor Ardoin gave an update on business items from last month's meeting, and advised that he needed to add an item to the agenda.

Motion by Robin, seconded by Barron to amend the agenda to add the sale of the Fruit of the Loom building. Mayor Ardoin polled the council and the vote is as follows: Robin - yea; Barron - yea; Hardy - yea. Motion carried by unanimous vote.

Motion by Hardy, seconded by Barron granting Mayor Ardoin permission to execute all documents regarding the sale of the Fruit of the Loom building. Mayor Ardoin polled the council and the vote is as follows: Robin - yea; Barron - yea; Hardy - yea. Motion carried by unanimous vote.

Motion by Robin, seconded by Barron setting the time at 6:00 p.m. and selecting the following dates for the town council meetings to be held in the year 2020: Tuesday, January 7, Wednesday, February 5, Tuesday, March 3, April 7, May 5, June 2, July 7, August 4, September 1, October 6, November 3, and Wednesday, December 1. Unanimous.

Motion by Barron, seconded by Hardy, upon the recommendation of Chief Boudreaux, to hire Christy Janise and Richard Baudoin as full-time, post-certified police officers. Unanimous.

Mayor Ardoin called upon Chief Deon Boudreaux. Chief Boudreaux rendered his monthly report.

Mayor Ardoin called upon Supervisor of Public Works, Chad Mayer. Mr. Mayer rendered his monthly activities and work order report.

Mayor Ardoin called upon Parks and Recreation Director, Hannah Levet. Ms. Levet rendered her monthly report on activities.

Motion by Robin, seconded by Hardy accepting all financial and departmental reports. Unanimous.

Mayor Ardoin called upon the Town Council, then the audience. General discussion was had, including current internet service providers, and the possibility of getting new providers to come in to Port Barre.

Motion by Robin, seconded by Hardy to adjourn. Unanimous.
