REGULAR MEETING

A public hearing was held in the Town Hall from 5:30 p.m. to 6:00 p.m. to allow citizens to provide comments and opinions on the adoption of Ordinance No. 1 of 2019, Amending Town of Port Barre Original Code of Ordinances Part 8, Health and Sanitation, Chapter 2 Weeds. The Ordinance was read in its entirety with several citizens present. There was minimal discussion regarding adoption of this ordinance.

Mayor Ardoin closed the public hearing at 6:00 p.m. The Mayor and Board of Aldermen/Alderwoman of the Town of Port Barre met in regular session in the Town Hall on Tuesday, June 4, 2019, at the hour of 6:00 p.m.

Mayor Ardoin called the meeting to order. Present were: Pickney, Robin, Abshire, Barron and Hardy. Absent: None.

The Mayor and Board of Aldermen/Alderwoman of the Town of Port Barre, Parish of St. Landry, State of Louisiana, were duly convened as the governing authority of said town by the Honorable Mayor, John P. Ardoin, whom stated that the Council was ready for the transaction of business.

Motion by Abshire, seconded by Pickney, accepting the Minutes of the May 7, 2019, Regular Meeting and to dispense with the reading thereof. Unanimous.

Mayor Ardoin gave an update on business items from last month's meeting.

Motion by Pickney, seconded by Barron adopting Ordinance No. 1 of 2019, Amending Town of Port Barre Original Code of Ordinances Part 8, Health and Sanitation, Chapter 2 Weeds. Unanimous.

Mayor Ardoin called for any and all bids for the demolition of the condemned properties.

Cajun Choppers, LLC, 273 Clayton Road, Port Barre, LA 70577 was the only company to submit bids as follows:

- 170 Josie Street \$7,850.00
- 128 Josie Street \$3,000.00
- 144 East Courtableau \$2,750.00
- 125 Bayou Drive \$2,750.00

Motion by Pickney, seconded by Barron granting Mayor Ardoin permission to accept the bids and proceed with the demolition as he deems fit. Unanimous.

Mayor Ardoin called upon Chief Boudreaux. Chief Boudreaux rendered the monthly police department report of activities and gave an update on their Youth Mentoring Program.

Mayor Ardoin called upon Chad Mayer, Public Works Supervisor, who rendered his monthly activity report.

Motion by Robin, seconded by Hardy accepting all financial and departmental reports. Unanimous.

Mayor Ardoin called upon the town council, then the audience. General discussion was had, including continuation of the gas repairs, employee retirement, the U.S. Flag Project and "open trash burning." Ordinance No. 2 of 2019, Display of "911" Physical Address on Home And/or Business was introduced by Alderman Hardy.

Motion by Pickney, seconded by Robin to adjourn. Unanimous.
