COUNCIL PROCEEDINGS

APRIL 6, 2021

REGULAR MEETING

The Mayor and Board of Aldermen/Alderwoman of the Town of Port Barre met in regular session in the town hall on Tuesday, April 6, 2021, at the hour of 6:00 p.m.

Mayor Ardoin called the meeting to order. Present were: Pickney, Barron, Robin and Hardy. Absent: Abshire.

The Mayor and Board of Aldermen/Alderwoman of the Town of Port Barre, Parish of St. Landry, State of Louisiana, were duly convened as the governing authority of said town by Mayor John P. Ardoin, whom stated that the Council was ready for the transaction of business.

Motion by Pickney, seconded by Robin, accepting the minutes of the Regular Meeting held on March 2, 2021, and to dispense with the reading thereof. Unanimous.

Mayor Ardoin gave an update on business items from last month's meeting.

Mayor Ardoin called upon Mr. Burton Kolder with the accounting firm of Kolder, Slaven & Company to present the annual audit of the Town of Port Barre.

Motion by Robin, seconded by Hardy accepting the annual audit for fiscal year October 1, 2019 to September 30, 2020. Unanimous.

Motion by Robin, seconded by Barron adopting a resolution adopting a Citizen Participation Plan and a Procurement Policy in accordance with LCDBG requirements. Unanimous.

Motion by Pickney, seconded by Hardy proclaiming the Month of April, 2021 as "Fair Housing Month." Unanimous.

Motion by Hardy, seconded by Barron proclaiming the week of April 5-9, 2021 as "Community Development Week." Unanimous.

Motion by Robin, seconded by Barron adopting the Municipal Water Pollution Prevention Resolution and submit to DEQ. Unanimous.

Mayor Ardoin called upon Chief Boudreaux, who rendered his monthly report of police department activities. Chief Boudreaux presented commendations to Officers Alton Miller and Kevin Serialle for outstanding service and dedication to the Town of Port Barre. Chief Boudreaux also promoted Lt. Robert Hardy, III to Assistant Chief of Police.

Mayor Ardoin called upon Gregory Leger, Town Superintendent, who gave an update on public works activities.

Motion by Pickney, seconded by Hardy accepting all financial and departmental reports. Unanimous.


Motion by Pickney, seconded by Barron to go into "Executive Session" regarding personnel matters. Unanimous. Council went into session at approximately 6:48 p.m.

Motion by Robin, seconded by Hardy to return to "Regular Session." Unanimous. Council returned to regular session at approximately 7:01 p.m.

Mayor Ardoin called upon the Town Council, then the audience. General discussion was had including drainage and fireworks. Alderman Hardy introduced Ordinance No. 3 of 2021 regarding compensation of the Town Clerk and Superintendent.

Motion by Robin, seconded by Barron to adjourn. Unanimous.
