COUNCIL PROCEEDINGS

DECEMBER 2, 2020

REGULAR MEETING

The Mayor and Board of Aldermen/Alderswoman of the Town of Port Barre met in regular session in the town hall on Wednesday, December 2, 2020, at the hour of 6:00 p.m.

Mayor Ardoin called the meeting to order. Present were: Pickney, Barron, Robin, Abshire and Hardy. Absent: None.

The Mayor and Board of Aldermen/Alderswoman of the Town of Port Barre, Parish of St. Landry, State of Louisiana, were duly convened as the governing authority of said town by Mayor John P. Ardoin, whom stated that the Council was ready for the transaction of business.

Motion by Pickney, seconded by Barron, accepting the minutes of the Regular Meeting held on November 3, 2020, and to dispense with the reading thereof. Unanimous.

Mayor Ardoin gave an update on business items from last month's meeting, and requested permission to rent an excavator and hydraulic dump trailer if the Parish does not come in an clean up debris from the hurricanes.

Motion by Barron, seconded by Hardy giving Mayor Ardoin permission to rent an excavator and hydraulic dump trailer to clean up. Unanimous.

Motion by Robin, seconded by Barron setting the following time and dates for the monthly council meetings for the year 2021: 6:00 p.m. on Tuesday, January 5, February 2, March 2, April 6, May 4, June 1, July 6, August 3, September 7, October 5, November 2, and Wednesday, December 1. Unanimous.

Motion by Robin, seconded by Abshire to set forth the rules and regulations for the Bayou Teche RV Park with revisions. Unanimous.

Mayor Ardoin called upon Chief Boudreaux. Lt. Robert Hardy was in attendance on behalf of the Chief and presented the monthly report of the Police Department. Lt. Hardy, upon recommendation of Chief Boudreaux, asked the council to hire Mr. Kevin Serialle as a full-time, post-certified police officer.


Motion by Pickney, seconded by Hardy to hire Mr. Kevin Serialle as a full-time, post-certified police officer. Unanimous.

Motion by Robin, seconded by Barron accepting all financial and departmental reports. Unanimous.

Mayor Ardoin called upon the Town Council, then the audience. General discussion was had, including the sewer issue on Choctaw, repairs to equipment and loose dogs in town. Gregory Leger, Town Superintendent, gave an update on public works activities.

Motion by Abshire, seconded by Pickney to adjourn. Unanimous.
