## REGULAR MEETING

A public hearing was held in the Town Hall from 5:50 p.m. to 6:00 p.m. to allow citizens to provide comments and opinions on the adoption of Ordinance No. 6 of 2022, Sale of Immovable Property located at 122 W. Courtableau Drive to Jonathan Sebastien for the sum of \$17,350.00. There were several people in attendance with no comments or opinions expressed by anyone.

Mayor Ardoin closed the public hearing at 6:00 p.m. The Mayor and Board of Aldermen/Alderwoman of the Town of Port Barre met in regular session in the Town Hall on Tuesday, December 6, 2022, at the hour of 6:00 p.m.

Mayor Ardoin called the meeting to order. Present were: Pickney, Robin, S. Hardy and G. Hardy. Absent: Abshire.

The Mayor and Board of Aldermen/Alderwoman of the Town of Port Barre, Parish of St. Landry, State of Louisiana, were duly convened as the governing authority of said town by the Honorable Mayor, John P. Ardoin, whom stated that the Council was ready for the transaction of business.

Motion by Robin, seconded by S. Hardy approving the minutes from the Regular Meeting on November 1, 2022 and to dispense with the reading thereof. Unanimous.

Mayor Ardoin gave an update on business items from the November 1, 2022 meeting.

Motion by Pickney, seconded by S. Hardy adopting Ordinance No. 6 of 2022, Sale of Immovable Property located at 122 W. Courtableau Drive to Jonathan Sebastien for the sum of \$17,350.00. Unanimous.

Motion by Robin, seconded by G. Hardy accepting the base bid of Trek, Inc. in the amount of \$839,261.00 for the Water Treatment Facility upgrades. Unanimous.

Motion by G. Hardy, seconded by Robin setting the monthly meetings of the Mayor and Town Council for the year 2023 as follows: Tuesday, January 3, February 7, March 7, April 4, May 2, June 6; Wednesday, July 5; Tuesday, August 1, September 5, October 3, November 7 and December 5. Unanimous.

Mayor Ardoin called upon Chief Deon Boudreaux who presented the monthly report of police department activities.

Mayor Ardoin called upon Superintendent Greg Leger who presented the monthly report of public works activities.

Motion by S. Hardy, seconded by G. Hardy accepting all financial and departmental reports. Unanimous.

Mayor Ardoin called upon the Town Council, then the audience. Alderman Robin introduced Ordinance No. 1 of 2023, Compensation of the Chief of Police. General discussion was had, including the street and water treatment facilities projects, as well as the Town's applications for additional grant funding.

Motion by Pickney, seconded by S. Hardy to adjourn. Unanimous.
