REGULAR MEETING

The Mayor and Board of Aldermen/Alderwoman of the Town of Port Barre met in regular session in the town hall on Tuesday, January 6, 2026, at the hour of 6:00 p.m.

Mayor Ardoин called the meeting to order. Present were: Hebert, Robin, Kimble, S. Hardy and G. Hardy. Absent: None.

The Mayor and Board of Aldermen/Alderwoman of the Town of Port Barre, Parish of St. Landry, State of Louisiana, were duly convened as the governing authority of said town by Mayor John P. Ardoин, whom stated that the Council was ready for the transaction of business.

Motion by Hebert, seconded by S. Hardy, accepting the minutes of the Regular Meeting held on December 2, 2025, and to dispense with the reading thereof. Unanimous.

Motion by G. Hardy, seconded by Kimble to advertise for bids for demolition and clean up of the property located at 125 Josie Street. Unanimous.

Motion by Kimble, seconded by S. Hardy accepting the resignation of Officer Christy Janise effective December 15, 2025. Unanimous.

Mayor Ardoин called upon Chief Boudreaux, who rendered the monthly report of Police Department activities. He also requested that the dog kennels located at the sewer treatment plant be repaired.

Mayor Ardoин called upon Superintendent Greg Leger who gave an update on public works activities, including the upgrade project at the water distribution site. He also advised that they have started replacing all of the stop signs in town and that the street name signs would be next.

Mayor Ardoine called upon Parks & Recreation Director Kyla Rivette who gave an update on youth league activities.

Motion by Donald, seconded by S. Hardy accepting all financial and departmental reports. Unanimous.

Mayor Ardoine called upon the Council, then the audience. General discussion was had, including the sidewalk project, mayor updates, consideration of live council meetings, and motorized scooters and bicycles on the roadways being dangerous.

Motion by S. Hardy, seconded by G. Hardy to adjourn. Unanimous.
