COUNCIL PROCEEDINGS

NOVEMBER 1, 2022

REGULAR MEETING

The Mayor and Board of Aldermen/Alderswoman of the Town of Port Barre met in regular session in the town hall on Tuesday, November 1, 2022, at the hour of 6:00 p.m.

Mayor Ardoin called the meeting to order. Present were: Pickney, Robin, S. Hardy and G. Hardy. Absent: Abshire.

The Mayor and Board of Aldermen/Alderswoman of the Town of Port Barre, Parish of St. Landry, State of Louisiana, were duly convened as the governing authority of said town by Mayor John P. Ardoin, whom stated that the Council was ready for the transaction of business.

Motion by Pickney, seconded by Robin, accepting the minutes of the Regular Meeting held on October 4, 2022, and to dispense with the reading thereof. Unanimous.

Mayor Ardoin gave an update on business items from the October 4, 2022 meeting.

Motion by Robin, seconded by S. Hardy adopting a Resolution authorizing Mayor Ardoin to act and perform all duties, sign and submit all documents and applications, and commit to providing additional funds regarding the Delta Regional Authority grant, if funded, and, if there is an administration change, the new Mayor shall continue to have such authority. Unanimous.

Mayor Ardoin called upon Chief Boudreaux. Assistant Chief Robert Hardy was in attendance and presented the monthly report of police department activities.

Mayor Ardoin called upon Superintendent Greg Leger who gave an update on public works activities.

Motion by S. Hardy, seconded by Pickney to accept all financial and departmental reports. Unanimous.

Mayor Ardoin called upon the Town Council, then the audience. General discussion was had, including the water well upgrades, street project, cameras in Veterans' Memorial Park, Second Harvest Food Bank, Flag Football program, Christmas parade set for December 3, 2022 and the Lighting of the Bridge event. Alderman S. Hardy introduced Ordinance No. 6 of 2022, Sale of the property located at 122 West Courtableau.

Motion by Pickney, seconded by S. Hardy to adjourn. Unanimous.
