REGULAR MEETING

A public hearing was held in the Town Hall from 5:30 p.m. to 6:00 p.m. to allow citizens to provide comments and opinions on the adoption of Ordinance No. 2 of 2020, regulating the development and construction of residential and commercial subdivisions within the corporate limits of the Town of Port Barre. The ordinance was read, a few citizens were present, and no comments or opinions were expressed.

Mayor Ardoin closed the public hearing at 6:00 p.m. The Mayor and Board of Aldermen/Alderwoman of the Town of Port Barre met in regular session in the Town Hall on Tuesday, October 6, 2020, at the hour of 6:00 p.m.
