A public hearing was held in the Town Hall from 5:50 p.m. to 5:55 p.m. to allow citizens to provide comments and opinions on the adoption of Ordinance No. 3 of 2025, Compensation of Superintendent and Ordinance No. 4 of 2025, Compensation of Town Clerk. No comments or opinions were expressed.

Mayor Ardoin closed the public hearing at 5:55 p.m. The Mayor and Board of Aldermen/Alderdwoman of the Town of Port Barre met in regular session in the Town Hall on Tuesday, October 7, 2025, at the hour of 6:00 p.m.

Mayor Ardoin called the meeting to order. Present were: Robin, Hebert and Kimble. Absent: S. Hardy and G. Hardy.

The Mayor and Board of Aldermen/Alderdwoman of the Town of Port Barre, Parish of St. Landry, State of Louisiana, were duly convened as the governing authority of said town by the Honorable Mayor, John P. Ardoin, whom stated that the Council was ready for the transaction of business.

Motion by Kimble, seconded by Hebert approving the minutes from the Regular Meeting on September 2, 2025 and Special Meeting on September 23, 2025. Unanimous.

Motion by Robin, seconded by Kimble adopting Ordinance No. 3 of 2025, Compensation of Superintendent. Unanimous.

Motion by Robin, seconded by Hebert adopting Ordinance No. 4 of 2025, Compensation of Town Clerk. Unanimous.

Mayor Ardoin called upon a member of the Lions Club regarding the 2025 Cracklin Festival and use of Veteran's Memorial Park. Mrs. Desiree Ardoin was present on behalf of the club and requested permission to use Veteran's Memorial Park from November 9 through 16, 2025 for their annual Cracklin Festival.

Motion by Kimble, seconded by Robin granting permission to the Port Barre Lion's Club to use Veteran's Memorial Park from November 9 through 16, 2025. Unanimous.

Motion by Kimble, seconded by Robin to re-hire Mr. Robert L. Hardy, III as the Assistant Chief of Police at the salary he had before he resigned. Unanimous.

Mayor Ardoin called upon Chief Boudreaux who rendered the monthly report of Police Department activities. Chief Boudreaux also advised that he is looking into installing cameras throughout the Town utilizing the grant money awarded to the Police Department.

Mayor Ardoin called upon Superintendent Greg Leger who gave an update on public works activities.

Mayor Ardoin called upon Parks and Recreation Director Kyla Rivette. Ms. Rivette was not present. Mayor Ardoin gave an update on Youth League activities, and advised that he and Kyla would be meeting with an architect regarding the Glass Systems building.

Motion by Hebert, seconded by Robin accepting all financial and departmental reports. Unanimous.

Mayor Ardoin called upon the Council, then the audience. General discussion was had, including upgrades at the water well site and the discoloration of the water, tall grass and trash in yards, blighted property, cutting down of two trees on Ellis and Camilla Streets and trimming of trees at the library.

Motion by Hebert, seconded by Robin to adjourn. Unanimous.
