SPECIAL MEETING

A public hearing was held in the Town Hall from 5:30 p.m. to 6:00 p.m. to allow citizens to provide comments and opinions on the proposed budget for the fiscal year beginning October 1, 2023 and ending September 30, 2024, and proposed amendments to the budget for the fiscal year ending September 30, 2023.
